





General Session Speaker Biographies

Jerry Kaproth

A native of Minnesota, Jerry Kaproth is a Manager of Testing Logistics and Track Safety and Surface for NASCAR. Kaproth's responsibilities include investigating the results of race incidents and aiding NASCAR's engineering group with accident reconstruction. He is an entertaining speaker that will discuss how NASCAR tracks are designed, constructed, and maintained for friction and wear. He will also discuss how the surface is then tested in order to enhance the product.

Bill McCoshen

Bill McCoshen is the Managing Partner of Capitol Consultants, a firm specializing in government relations, public affairs and issues-based grassroots advocacy. Before joining Capitol Consultants, Bill was appointed by Governor Tommy Thompson to be the first Secretary of the Wisconsin Department of Commerce in state history. He was responsible for assisting citizens, businesses and communities with financing and economic development programs. At the age of 29, Bill was the youngest cabinet secretary ever appointed in Wisconsin history. Prior to being appointed the Secretary of Commerce, Bill was the manager of Governor Thompson's historic third-term campaign victory. The landslide 68% victory was the second highest margin in state history and the largest margin since 1922. The '94 reelection

campaign captured 71 of 72 counties, and Governor Thompson received more votes than any gubernatorial candidate in history. At age 27, Bill also served as Governor Thompson's chief of staff.

Michael Groh

Mike Groh has been associated with the paving industry for four decades. His experience has been as a contractor, material supplier, and consultant with over twenty of his 40+ years working primarily in the consulting industry. Mike incorporated Pavement Consultingi LLC (PCI) in 2014 with the objective of introducing new and innovative pavement management concepts to the industry. Integrating innovative design and construction techniques ensures clients of PCI are benefiting from this innovative approach.

Tim Murphy

Tim Murphy, President of Murphy
Pavement Technology, Inc., promotes
best management practices within the
asphalt industry on the local, regional, and
national levels. He works collaboratively
with agencies, associations, consultants,
material suppliers, and contractors
to assure asphalt quality in roadway,
runway, and commercial and industrial
construction. Tim assisted in the writing of
the Asphalt Institutes MS-22 Construction
of Hot Mix Asphalt Pavements and currently
travels the country training asphalt

professionals for the National Highway
Institute on asphalt plant production. Most
recently he served as a writer and outside
reviewer of the Asphalt Institute MS-2
Asphalt Mix Design Methods, 2015 version.
Tim is happy to work alongside WisDOT,
WAPA, and industry here in Wisconsin
while teaching the Asphalt Pavement
Maintenance course each winter with
UW – Madison and performing Wisconsin
contractor audits annually.

Mike Acott

Mike Acott is President of the National Asphalt Pavement Association (NAPA), the national trade association representing the asphalt paving industry in the USA. Mike was also a past Chairman of the Global Asphalt Pavement Alliance, which includes the paying industry from Japan. Australia. New Zealand, Europe, South Africa, and Mexico. His career activities involve more than 30 years of experience in the pavement industry in Europe, South Africa, and the United States, including experience with aggregate and bitumen suppliers, and management of an asphalt construction company. He has been the President of NAPA since 1992, and has helped develop partnerships with Government and Union partners that have resulted in an improved workplace environment. This has included successful national initiatives on engineering controls, warm mix, and best practices that have resulted in reduction in

workplace exposure. Mr. Acott has authored and co-authored numerous publications and reports on various facets of asphalt pavement design, construction, and materials technology. Mike was inducted into NAPA's Asphalt Pavement Hall of Fame in February 2014.

Ester Magorka

Ester Magorka joined NAPA in 2005 and performed a variety of tasks for the association working in the meetings, accounting, government relations, and marketing departments. Currently, Ester serves as Vice President for Marketing where she works with partners to manage the asphalt pavement industry's brand, public relations programs, and outreach efforts under the Go-To-Market program. Her focus is the preservation of the industry's market share through a comprehensive marketing and communications program aimed at educating agencies on the advantages of asphalt. The program takes scientific research reports and packages it in a way that is authentic, persuasive, and dynamic. Ester holds a Master of Business Administration from the University of Maryland, University College and two undergraduate degrees in Political Science and Philosophy from Salisbury University.

General Session Speaker Biographies

Mike Davies

Mike Davies is the Wisconsin Division Administrator for the Federal Highway Administration. He is responsible for administering the stewardship and oversight of the Federal-aid highway program in the State of Wisconsin. Prior to his appointment as Division Administrator, Mr. Davies served as the FHWA's Director of Project Delivery and Engineering Services for FHWA's Central Federal Lands Highway Division, Mr. Davies has also served as the Assistant Division Administrator in New York where he advanced Every Day Counts initiatives. He has over 30-years of transportation experience. He has a Bachelor of Science degree in Civil

Engineering from the University of Alaska and a Master of Science degree in Civil Engineering from the University of Maine. He is a registered professional engineer.

Chris Wagner

Chris is the Team Manager for the FHWA Pavement and Materials Technical Services Team. His main areas of expertise include implementation of Asphalt Technologies and the Mechanistic Empirical Pavement Design Guide. He has worked with all 50 State Highway Agencies in the development, deployment and adoption of these technologies. Chris earned his Bachelor's and Master's degrees in Civil Engineering from Auburn University.

















Technical Breakout Session Summaries

Perpetual Pavements (1 PDH)

Dr. David Timm, Auburn University

Pavements subject to extreme loading conditions can require increased pavement thicknesses. With the requirement for thicker cross section pavements, heavy-duty pavements often are great candidates for employing a perpetual pavement or a long life pavement design. A perpetual pavement design solution can also provide an attractive solution for heavy-duty pavements due to the increased service life in critical corridors where user delay is costly.

Pavement Preservation (1 PDH)

Deb Schwerman, WAPA

To ensure drivability and performance, aging infrastructure requires periodic maintenance and rehabilitation. Smart, effective, economic strategies for pavement preservation and maintenance exist, but have not always been deployed at the right time or manner. This session investigates different options available for maintaining asphalt pavements and why maintenance and rehabilitation are important for the industry.

Design and Construction (1 PDH)

Mark Blow, Asphalt Institute

Accurate design and construction are essential to achieve desired pavement performance. This session will highlight proper thickness design, asphalt mix type, and binder selection. Construction best practices will include tack coat application, longitudinal joints, and density.

Ethics Training (1 PDH)

Cindy Buchko, Construction Business Group

Back by popular demand, this session will focus on the fundamental canons of professional conduct and other appropriate administrative rules and regulations. The discussion is designed to demonstrate a working knowledge of professional ethics and satisfy the requirement for "professional conduct and ethics".

Back to Basics: Paving (1 PDH)

Kevin Jeske, Carlson Paving

Placing a smooth, uniform asphalt pavement begins with proper operation of the paving machine. This session highlights the different parts of a paver, as well as paver set-up and operation, and how it all contributes to ensuring a pavement with a high level of drivability.

Back to Basics: Compaction (1 PDH)

Tim Kowalski, Wirtgen Group

Compaction rollers are used to achieve the density a pavement needs to ensure performance and longevity, as well as to create a well-finished surface. This session will discuss different types of rollers, their use, and how to determine proper compaction and coverage.




